Said notice stated the agenda is readily available for public inspection at the Superintendent's office during normal business hours. Board members were emailed notice of the meeting. VI. INFORMATION AND PROPOSALS

VI.1. PRINCIPALS' REPORTS

Middle School Principal Jay Vance reminded everyone to provide their LCCPRIDE feedback. They are still accepting feedback from the community. The Driver's Ed schedule is being created and they hope to begin classes in early April. He gave an update on BlendEd Training.

Elementary School Principal Paige Parsons reported on staff attending NAG Conference (Nebraska Association for the Gifted) and information they acquired. Science Standards are being reviewed for implementation and textbook update. Textbook adoption cycle for this year is Social Studies, Music, Math (Envisions).

Mr. Vance introduced Middle School Student Council members Sarah Karnes, Maddy Graham, and Allison Babl. They shared a video on LCC Middle School and the pride they have in their school. They prepared the video to submit to KTIV television for a contest. They did a great job. The Board thanked them for sharing the video and wished them good luck in the contest.

High School Principal Heath Johnson reported he has been consulting with Security Bank on the final steps for ordering the scoreboard. His written report also included State Speech is March 22nd with the following students competing: Brian Potts-District Champion-Extemporaneous, Kaylee Swanson-District Champion-Serious Prose, and Abby Bloom-3rd place-Humorous Prose. Track and Golf practice has started. The reVISION meeting was canceled due to snow, a new date has not been finalized. Mr. Vance, Mrs. Parsons, and Mr. Johnson continue to work on the schedule. ACT is Wednesday April 11th. National Honor Society Induction is March 29th at 9:00 a.m. Saturday April 14th is Prom.

VIII.1. Discussion Item about Frisbee golf.

Dwayne Freeman on behalf of the Laurel American Legion Post 54 and Laurel VFW Post 4504 visited with the Board to request funding for a proposed Frisbee/Disc Golf course to be installed near the football. He explained the benefits of the course for persons of all ages. He had visited with LCC physical education teacher Nate Sims and feels this is something the physical education classes could utilize. He provided details of the project including total costs of \$10,000 - \$11,000. Commitment for funds have been received from the Laurel Area Community Foundation Fund, City of Laurel, and Laurel American Legion Post 54 and Laurel VFW Post 4504. They will work to secure the remaining funds through private donations. The request will be considered by the school.

VI.2. SUPERINTENDENT'S REPORT

Superintendent Klooz reported that revenue shows an increase for this year as compared to last year at this time, and the expenditures have decreased. This information can be used to help the committees plan future projects.

The committee is researching the best plan for the future in regards to updates to the elementary rooms.
